My article this month was inspired by a recent experience I had while at the Courthouse and the words of Justice Sandra Day O'Connor, who said, "Certainly, life as a lawyer is a bit more complex today than it was a century ago. The ever-increasing pressures of the legal marketplace, the need to bill hours, to market to clients, and to attend to the bottom line, have made fulfilling the responsibilities of community service quite difficult. But public service marks the difference between a business and a profession. While a business can afford to focus solely on profits, a profession cannot. It must devote itself first to the community it is responsible to serve. I can imagine no greater duty than fulfilling this obligation. And I can imagine no greater pleasure." 78 Or.L.Rev. 385, 391 (1999).

In mid-December 2021, I arrived early for my morning hearing and approached the B.F. Sisk Courthouse to stand in line with others waiting for the 8 o'clock hour when the deputies open the front doors. It was extremely cold that morning! As I stood shivering outside, trying to gather my thoughts about arguments I would make to the Judge that morning and decompress from my morning chaos which involved getting the kids dressed, fed, and to school on time before arriving at Court, I took a moment to observe my surroundings. I was saddened by what I saw. On the ledge outside the courthouse to my right, I observed a woman bundled up in a blanket who was chattering words to herself only she could understand. Across the street by the water tower, I observed a person asleep in a sleeping bag on the cement trying to stay warm. In front of the parking lot area, there was a person in shorts and sandals with a shopping cart which was being used to house her belongings. Seeing this, made me pause and recognize how grateful I am for everything I have been blessed with, but it also made me more aware of the need that exists within our own community, and the importance of promoting FCBA's Mission, "To Assist the Community, It Serves." Martin Luther King Jr. said, "Life's persistent and most urgent question is, 'What are you doing for others?" While the thought of adding one (1) more "To Do" to your "To Do List" may seem like an impossibility when you consider your protessional responsibilities coupled with those of your home and family life, I invite you to consider getting involved and giving back to our community if you are not already doing so. Our profession provides us with so many opportunities to give back. To some, your interests may be in giving back to the homeless. Others may prefer giving back to U.S. Veterans, victims of domestic violence at the Marjaree Mason Center, to provide pro bono legal services to an indigent party, to help local children with Mock Trial or Moot Court Competitions, to volunteer your time as a mentor to a new attorney or to the Fresno County Superior Court as a Judge Pro Tempore, or simply by donating money. The opportunities are endless. On December 18, 2021, the FCBA Board (present and former members), our FCBA team, Anita and Angelica, and their families took part in a gift-wrapping event at the Poverello House. For those of you who don't know, the Poverello House is located in downtown Fresno. It provides "three meals a day, 365 days a year to men, women, and families along with services that improve people's quality of life. These services include, clothing distribution, emergency food bags, a medical clinic, the Men's Resident Rehabilitation program, temporary overnight shelter for men and women, and social services for individuals seeking to end their

Superior Court Judge Ana de Alba Nominated to the Federal Bench

President Joe Biden has announced his intent to nominate Fresno County Superior Court Judge Ana de Alba to the U. S. District Court for the Eastern District of California. It's a court that has long suffered from a shortage of judges, to the point where judicial officials halted all new civil cases last year in that court due to the backlog. In December, some relief came with the confirmation of Federal Magistrate Judge Jennifer Thurston to the U. S. District Court. She had previously been assigned as a magistrate judge in Bakersfield.

U.S. District Judge Lawrence O'Neill frequently decried the lack of judges and the "crushing caseload" of the court. In 2019 he sent a letter to CA. Senators Dianne Feinstein and Kamala Harris saying, in part, "I write this letter out of concern for some 8.5 million people who live in the Eastern District of California, with my intention to prevent an impending, acute, and judicial catastrophe," When Judge O'Neill retired in 2020, the Fresno Division of the Federal Court was left with only one active Article III judge and one senior Article III judge. At the time, each of the court's district judges was handling about 900 cases at any given time, compared to a national average of 425 cases. O'Neill projected that would jump to approximately 1,350 per judge with his and another judge's imminent retirement.

de Alba has been a Fresno County Superior Court Judge since her appointment by then-Gov. Jerry Brown in 2018. She was up for reelection in 2020, but did not draw an opponent, retaining her seat by default. She currently handles juvenile justice cases. Before her elevation to the bench, de Alba was a partner at Lang Richet & Patch where she focused on employment, business, tort, and construction litigation. Judge de Alba received her J.D. from the University of California, Berkeley, School of Law in 2007 and her B.A. from the University of California, Berkeley in 2002.

de Alba was one of eight new federal judicial nominees announced by the White House on January 19th. As the Bar Bulletin heads to press, de Alba is awaiting both the official nomination from the President and a hearing before the Senate Judiciary Committee.

If approved by the Senate, the 42-year-old will become the first Latina ever to serve on the Eastern District of California Court and the second Hispanic judge actively serving on that court.



In Honor of Black History Month

After graduation from what is now Berkeley Law in 1929, Annie Virginia Stephens Coker became the first African-American woman to pass the Bar in CA. In 1939, she joined the CA State Office of Legislative Counsel, where she practiced until she retired in 1966. FACTS/CONTENTIONS

According to the plaintiffs' lawyer: Paul Perkins, a 64-year-old insurance estimator, his wife, plaintiff Rosemary Perkins, age 64, and their neighbor and friend, plaintiff Maria Rosas-Calderon, age 41, were traveling south on Terminal Avenue between Riverbank and Modesto March 1, 2017. Terminal Avenue is a 2-lane road without any adjacent improvements, lights or fog lines. Waterworks Industries Incorporated's employee, William Borges Jr., drove north in a 2011 Ford F-350 company-owned pick-up truck. The left front of defendant Borges' pick-up truck struck the left front of plaintiffs' pick-up truck at an estimated 125 miles per hour. Paul was killed instantly and Rosemary and Rosas-Calderon suffered injuries. Defendant Borges sustained a scratch to his finger. Data retrieved from defendants' pick-up truck reportedly showed that defendant Borges' speed at the time of impact was 70 miles per hour. The posted speed limit for the road was 55 miles per hour. The data also allegedly showed that there were no steering movements to avoid the impact or any braking during the 5 seconds before impact.

Plaintiff Rosas-Calderon settled her case for a total of \$75,000.

The case proceeded to jury trial on plaintiff Perkins' wrongful death and individual claims.

Jurors found defendants 100 percent at fault.

CLAIMED INJURIES

According to the plaintiffs' lawyer: Plaintiff Perkins: Death of spouse; broken jaw wired shut for 60 days; tibial plateau fracture. Plaintiff Ross-Calderon: fractured sternum.

CLAIMED DAMAGES

Not reported.

SETTLEMENT DISCUSSIONS

According to the plaintiffs' lawyer: Demand: \$5,600,000. Offer: \$3 million, increased to \$3.25 million 30 days before trial. The parties attended a mediation before David Abbott, who suggested settlement of \$4,000,000.

EXPERT TESTIMONY

According to the plaintiff's lawyer: Plaintiffs' expert Jeffrey Bonsall testified that based upon gouge marks in the roadway, the physical evidence to both vehicles and the data from defendants' truck, the impact occurred as much as 3 feet into plaintiffs' southbound lane. Defense expert Rajeev Kelkar, PhD, testified the impact occurred either on the center line or as much as 20 inches inside the southbound lane. He further testified defendant Borges was presented with a condition of imminent peril when he observed the headlights of plaintiffs' vehicle traveling in the northbound land and across the center line which caused Borges to move his vehicle to the east side of the road, causing him to leave the roadway surface. When he attempted to get back onto the roadway surface, he temporarily lost control of his vehicle, causing him to travel across the northbound lane and into the southbound lane. Both experts agreed the impact occurred in the southbound lane.

COMMENTS

According to court documents: The complaint was filed Oct. 4, 2018. According to the plaintiffs' lawyer: The defendants maintained an auto liability policy issued by Liberty Mutual in the amount of \$1,000,000 and a general liability policy issued by Navigators/Hartford in the amount of \$5,000,000. According to the plaintiff's attorney, the trial lasted 9 days, the jury vote was unanimous, and deliberations lasted 2 hours and 20 minutes.

Plaintiffs brought claims alleging wrongful death and vehicle negligence. They argued defendants' vehicle crossed over the center line and into the southbound lane, causing the incident.

Defendants contested liability and argued Paul drove either on or over the skip-striped middle line. An independent witness who was traveling behind the Perkins vehicle reportedly testified that the Perkins vehicle was traveling southbound and either crossed or was near the center line during the moments before the impact.
